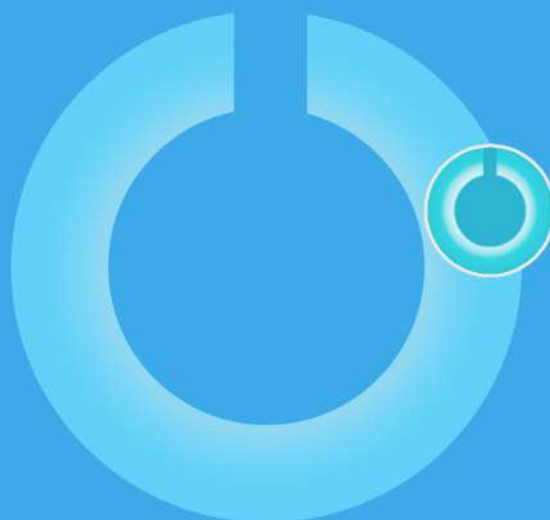

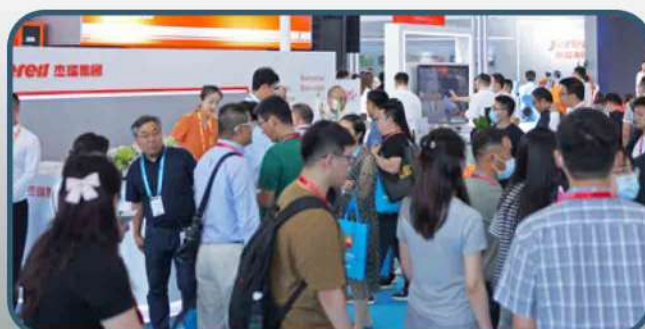

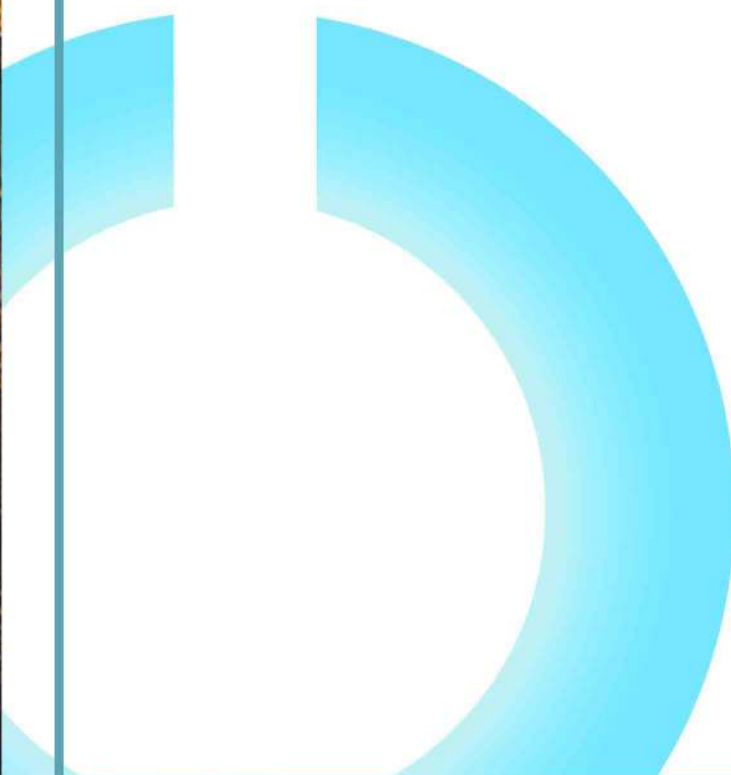

1. Application for space on the Exhibition shall be made on the form overleaf and shall be duly signed by the Exhibitor or a person authorized by him. Following receipt of the Application together with initial payment. All special decoration must be approved by the organizer.
2. The payment schedule for space only, shell stand is as follows
I. 50% with submission of application.
II. 50% by date specified on the application, where the application is made after the final payment date that specified on the Application, the total amounts shall be paid.
The total price represents only the payment for the space, details of which are set out overleaf. All other goods and services required by the exhibitors shall be paid by the exhibitors. In addition, exhibitors will not be allowed to take over their space or stands.
3. In addition to the space price. (And stand fitting service when applicable), exhibitors will be billed for optional services requested; such as hired furniture, power supply, telephone lines. show catalogue advertisements and other.
4. If the organizer agrees to a cancellation of the space contract, the exhibitor will be liable for all or part of the contract price depending on when the cancellation request will receive.
if 90 days prior to the exhibition's opening date 50% of total amount, if 30 days prior to the exhibition's opening date 100% of total amount, if less than 30 days prior to the exhibition's opening date, in addition to the cancellation charges, the exhibitor will be liable for any specific cost that imposed on the organizer. These terms cannot be varied under any circumstances.
5. An exhibitor who fails to exhibit for any reason, shall be liable for the full amount of the contract plus additional amounts incurred by the organizers on the exhibitor's behalf.
6. If an exhibitor declares bankruptcy, the contract with such an exhibitor shall be cancelled and any moneys already paid, shall be retained by the organizers.
7. The organizers or their servants or agents shall not be liable for the safety of Exhibitor's staff, agents, contractors or invitees during the exhibition, and will not be liable for any products, goods or other property of whatever kind brought into the exhibition by exhibitors.
8. All contracts and services provided by the organizers, are subject to these terms and conditions and organizers reserve the right to alter, add to, or amend any of these conditions in the contract.
9. All responsibility for building, installing, completing, changing or dismantling the booths or entering, placing or removing the goods is the responsibility of the exhibitor.
10. The contracted party for a stand, is responsible to be fully aware of their contract and agree to abide by.
11. The exhibitor must not transfer or sublet all or any part of his exhibition space, whether for financial consideration or otherwise. The exhibitor who is an agent or distributor or licensee, should mention the names of the principals at the time of application to be represented, this does not prohibit an exhibitor to displaying the products of a principal for whom he becomes a distributor or licensee after the time of application. with the prior written permission of the organizers, they can promote their products.
12. The organizers shall not be liable to the exhibitor by reason of any cancellation or part-time opening of the exhibition, either in whole or in part, for any non-performance of their obligations under this application or any amendments or iterations to all or more of the rules and regulations of the exhibition, each case to the extent that such occurrence is due to any circumstances not within the control of the organizers.
13. The organizers reserve the right to allocate the exhibition spaces in any way they think is in the public interest of the exhibition and place them at the exhibition site and to change the general layout or any specific type and even in case of allocation and contract, to help the exhibitor to accept such new space allocation.
